User Information Service Terms of Origin Quantum

Welcom to use the services provided by Origin Quantum Computing Technology (Hefei) Co., Ltd.(hereinafter referred to as" Origin Quantum"). You (hereinafter referred to the "User") should carefully read all of the following terms (especially the terms that are highlighted in bold).

Do not install or use Origin Quantum services if the user does not agree any content contained in the Service Terms herein. By downloading and accepting the Service Terms, it represents that the user has entered into this agreement with Origin Quantum and voluntarily accepts all contents contained in the Service Terms. Thereafter, the user cannot make any form of defense with an excuse of not reading the Service Terms herein.

1. Confirmation and acceptance of the Service Terms

The ownership and intellectual property of software products involved in Origin Quantum services are owned by Origin Quantum. Origin Quantum services must be provided strictly in accordance with the Articles of Association, Service Terms and Operation Rules released by Origin Quantum. The Service Terms apply to the products and services provided by Origin Quantum (hereinafter referred to "Origin Quantum Individual Service"). The user is bound by these Service Terms when enjoying any individual service provided by Origin Quantum. It is deemed that the user has agreed to the service clauses of individual service and various announcements released by Origin Quantum for such individual service (hereinafter referred to as "Individual Clauses") in the form of individual service requirements when enjoying any individual service provided by Origin Quantum. In such case, the individual clauses shall become effective simultaneously for the users with the Service Terms herein. If there is any conflict between the individual clauses and the Service Terms herein with regard to a similar clause, the individual clauses shall prevail within the binding coverage of such individual clauses.

2. Introduction to Origin Quantum services

Origin Quantum uses its own platform to offer a variety of services to the user via the Internet. The user must:

(1) Provide equipment such as personal computer, mobile phone or other internet access devices.

(2) Personally access the Internet and pay the costs associated with this service.

3. Confirmation of user Information

The user acknowledges to have the capacity of performing civil act adapting to his/her act stipulated by the laws of the People's Republic of China when using the products and services provided by Origin Quantum and ensures to have the capacity of being solely responsible for his/her use of Origin Quantum services. If the user does not qualify as a principal as mentioned above, the user should read these Service Terms accompanied by parents or other custodians (hereinafter referred to as the "Custodian"), and only use Origin Quantum services with the consent of the custodian to the use of Origin Quantum services and these Service Terms herein. Origin Quantum has the right to recover from the custodian when holding the users accountable in accordance with the provisions of laws or the requirements of these Service Terms herein.

Furthermore, the user also ensures that he/she is not the target of trade restrictions, sanctions or other restrictions by laws or rules enforced in any country, international organization or territory, does not offer the fund, commodity or service to the above-mentioned target in direct and indirect way. Otherwise, the user should stop registering and using Origin Quantum services while the user also understands the Origin Quantum services may not be used normally if violating the above requirements. When using Origin Quantum products, the user is committed to

complying with the law, regulation, socialist system, national interest, legitimate rights and interests of citizens, public order, social morals, information authenticity, etc., and does not have one of the following circumstances:

(1) Violating the requirements of the Constitutions, laws and regulations;

(2) Endangering national security, divulging state secrets, subverting state power and undermining national unity;

(3) Harming national honor and interest, and harming public interest;

(4) Inciting national hatred and discrimination and undermining national unity;

(5) Sabotaging the state's religious policies and propagating heresy and feudal superstition;

(6) Spreading rumors, disturbing social order or undermining social stability;

(7) Spreading obscenity, pornography, gambling, violence, murder and terror or abetting a crime;

(8) Insulting or slandering others and infringing on the legitimate rights and interests of others;

(9) Containing other contents that are prohibited by laws, administrative rules and regulations.

In accordance with the requirements of relevant laws and regulations, and considering the importance of Origin Quantum products and services, the user agrees:

To the extent permitted by laws and regulations, the user agrees that the service data and records related to the use of Origin Quantum products, including but not limited to all registration, login, consumption records and related use statistics, shall be owned by Origin Quantum. The user agrees to be subject to the system data of Origin Quantum in case of disputes and Origin Quantum guarantees the data authenticity.

4. Change of Service Terms

Origin Quantum reserves the right to change the Service Terms and clauses of each individual relevant service by releasing announcements on web pages and other reasonable ways when necessary. The user should timely consult and understand the changes when using each service, and voluntarily comply with the Service Terms and relevant clauses of individual service. If the user continues to use the service involved in the Service Terms, it shall be deemed the user has accepted the changes. The latest Service Terms shall prevail in case of dispute. The user has the right to stop using service involved in the Service Terms herein if not agreeing to the changes.

5. Change or termination of services

Origin Quantum constantly changes and improves its services. Origin Quantum may add or delete the function, temporarily or completely terminates a service. The user agrees that Origin Quantum may terminate the user information service due to its business decision and other reasons. In such case, Origin Quantum will notify The user in the form of announcement, and, except as expressly provided by laws, if the user makes violation or infringements evidenced by the effective legal documents issued by the state administration or judicial bodies, or, Origin Quantum determines by itself that the user's behavior is suspected of violating this agreement or the provisions of laws and regulations, Origin Quantum has the right to stop, suspend and terminate the services to the user without assuming any liabilities.

6. User Privacy System

It's a basic policy of Origin Quantum to respect the privacy of users. Origin Quantum will collect, store, use, disclose and protect the personal information of users according to the privacy policies published on its website. The user shall completely read the privacy policies to better protect personal information. For the user who is a minor under 14, the custodian must be notified to read the policies together, and give consent and guidance before the service is used and personal information is submitted.

7. Force Majeure

Origin Quantum is not liable for damages caused by force majeure. The force majeure referred to in these Service Terms includes: natural disaster, changes in laws, regulations or governmental directives, reasons specific to Internet service characteristics, e.g. failures in domestic and foreign infrastructure telecommunications providers, computer or Internet relevant technical defects, Internet coverage restriction, computer virus, hacker attack, and other objective situation that cannot be foreseen, avoided and overcome within the legal scope.

8. Prohibition of service commercialization

The user undertakes not to sell Origin Quantum services or use them for other commercial purposes without the approval of Origin Quantum. If the user needs to use the service for commercial purpose, the user shall notify Origin Quantum in written form and obtain explicit authorization from Origin Quantum.

9. Guarantee

The user agrees to safeguard and defend the interests of all Origin Quantum personnel, and agrees to pay the damages caused by the user's violation of these Service Terms herein and the expenses incurred by others using the user's computer, mobile phone and account. If any claim is brought by the infringed person for the infringement of intellectual property rights and other rights of the third party when the user is using account or other person is using the user's account, the user shall assume the liabilities.

If the user or other Internet service provider uses Origin Quantum services to infringe the civil rights and interests of others, the user shall be liable for infringement and other legal responsibilities together with such Internet service provider.

If the user uses Origin Quantum services to commit the acts of infringement, the infringed person has the right to notify Origin Quantum to delete, block, break links and take other necessary actions to the user. Origin Quantum shall assume legal liabilities for its failure to timely take necessary actions due to its own fault after receipt of the notice.

10. Notices

All notices issued to the user will be delivered via email, regular letter or announcement prominently appearing on the website. Origin Quantum will give messages to the users by one of the methods described above, informing them of changes to the Service Terms, service changes or other important matters.

11. Ownership

The contents provided by Origin Quantum include but not limited to: the text, software, sound, photo, video and charts uploaded/supplied by non-users. All these contents are owned by Origin Quantum and protected by copyright, trademark, patent and other property ownership laws. Therefore, the user cannot use these contents unless obtaining the authorization of Origin Quantum, and is forbidden to duplicate, reproduce or create derivatives related to these contents.

12. Laws

These Service Terms shall be governed by the laws of the People's Republic of China, without regard to the conflict of laws.

If there is a dispute arising from using the service hereunder, both parties shall settle it through friendly negotiation. If negotiation fails, the user agrees to submit it to the competent court where Origin Quantum is domiciled.

13. Miscellaneous

(1) Origin Quantum's failure or delay to exercise the rights or failure to exercise the rights in full under these Service Terms or entitled by the laws shall not be construed as a waiver of such right, nor affect Origin Quantum to exercise such right in future.

(2) If the whole or part of any clause under these Service Terms is held invalid or unenforceable for whatever reason, the remainder of the Service Terms shall be valid and binding. Origin Quantum and the user shall use reasonable endeavors to fulfill the intent incorporated by these Service Terms.

(3) The headings are for convenience only and shall not be used as basis for the interpretation of these Service Terms.
